3. BECi reserves the right to review all accounts on a regular basis for the purpose of determining adequate security deposits. At any time BECi determines an account to be a "loss" risk; a deposit of up to two and one half times the average monthly bill may be added to the account. _____ Initial
4. Applicant agrees to comply with and be bound by the provisions of the By-Laws of BECi of which he/she will be a member, and such rules and regulations as may, from time to time, be adopted by BECi, as established by the Public Service Commission of Louisiana. _____ Initial
